

## HISTORY OF THE COLLEGE

Saint Christopher's College of Medicine educational program was first offered in Cambridge, England in 1999 by Dr. Paul Leone.

Dr. Paul Leone secured financial backing for the educational program in the form of personal investment from Mr. Shaykh Hassan Ali Cissé, a religious leader in Dakar Senegal, and from his accountant, Mr. Firoz Ahmed Shaikh in New York.

Saint Christopher's College of Medicine was incorporated in Florida, USA in May 1999 by Dr. Paul Leone and Mr. Firoz Ahmed Shaikh. In 1999, the admissions and registrar functions were staffed by a very capable administrator, Ms Tricia Panella.

Under the leadership of the managing director, Dr. Paul Leone, and the financial director, Mr. Firoz Ahmed Shaikh, and in part due to the significant political influence of Mr. Shaykh Hassan Ali Cisse in Senegal, Saint Christopher's College of Medicine was authorized to grant the degree Doctor of Medicine in June 2000 by the Ministry of Health and the Ministry of Education in the Republic of Senegal.

Initially, the educational program consisted of only a pre-clinical curriculum taught in Cambridge utilizing part-time faculty from the University of Cambridge. The pre-clinical program in Cambridge was operated under the direction of Dr. Jeffries Mvenge of Zimbabwe, a former instructor at Kigezi International School of Medicine in Cambridge.

In 2001, Mr. Alan Bain joined Saint Christopher's College of Medicine from Kigezi International School of Medicine and became the director of operations of the pre-clinical program in Cambridge.

In 2001, Dr. Mark Best replaced Dr. Jeffries and was appointed the Dean of the Cambridge Program.

During 2001 and 2002, Dr. Paul Leone traveled between Cambridge and the United States to develop clinical training opportunities in the United States. During 2001, in particular, the student body consisted primarily of transfer students from other overseas medical schools who were in need of clerkships that could not be provided by these programs.

In 2001, Dr. Tah-Hsiung Hsu was appointed as Acting Clinical Dean because of his involvement with the clinical training of students of Saint Christopher's College of Medicine students and his academic association with Johns Hopkins University Hospital affiliates.

In 2001 and 2002, Dr. Paul Leone and Dr. Tah-Hsiung Hsu increased the number of hospitals affiliated with Saint Christopher's College of Medicine to over a half dozen. At present, however, the only hospital in the State of New York affiliated with Saint Christopher's College of Medicine is Jamaica Hospital in Long Island.

In 2001, student financial aid was established with The Educational Resource Institute (TERI). This provided at least some level of financial support for credit-worthy students.

In 2002, the pre-clinical program moved from Cambridge to Luton, approximately 30 miles north of London. The contractual agreement with the University of Luton, a former polytechnical university with no medical training program of its own, greatly enhanced the infrastructure available to Saint Christopher's College of Medicine. The affiliation with the University of Luton provided first-class classrooms, laboratories, dormitories and student facilities.

The primary benefit, however, that was bestowed upon Saint Christopher's College of Medicine by the move from Cambridge to University of Luton was the proximity to the London Medical Schools. The closer proximity to Kings and Guy's, in particular, meant that medical specialists in these leading medical schools could more easily travel from London to teach the pre-clinical students Saint Christopher's College of Medicine.

In 2002, the Office of Admissions and the Office of the Registrar moved from Naples, Florida to a temporary office in Melville, New York. Soon thereafter, a more suitable administrative office was found in Scotch Plains, New Jersey, near the office of Firoz Ahmed Shaikh, so that he could manage the finances and the day-to-day operations of the college.

In 2002, a key program administrator, Ms Angela Schroeder, moved to Luton from Naples, Florida, where she had served as Assistant Registrar. In Luton, Mr. Alan Bain managed the financial and contractual affairs of the pre-clinical program and Miss Angela Schroeder managed all other aspects and day-to-day operations of the growing pre-clinical program.

Of course, in order for Saint Christopher's College of Medicine to maintain degree-granting authority from Ministry of Health and Ministry of Education in Senegal, it is necessary to maintain a significant presence in that country and have an impact on health care education. Accordingly, key academic appointments were made in 2001 and 2002 in Dakar, Senegal, with the aim of establishing programs in medical education in Senegal.

In 2001, Professor Ibrahim Diop Mar was appointed Dean of the Dakar Campus. Shortly thereafter, Dr. El Hadji Ibrahima Diop, his son, was appointed Associate Dean of the Dakar Campus.

Under the academic leadership of Professor Ibrahim Diop Mar and Dr. El Hadji Ibrahima Diop, and Dr. Paul Leone, plans were fashioned for a six-year medical training program in French that could be developed in association with a hospital in Dakar, Senegal. Of course, the difficulties of developing such a lengthy clinical training program in Dakar, in French, require the cooperation of many governmental officials as well as the commitment on the part of Saint Christopher's College of Medicine to fund the program. Recently, the Ministry of Health in the Republic of Senegal selected the hospital that shall serve as the clinical training facility.

At present, the training of Saint Christopher's College of Medicine students does not include either pre-clinical or clinical training in Senegal. Simply stated, it is not practical to attempt either pre-clinical or clinical instruction in French to our students.

The Directors of Saint Christopher's College of Medicine remain committed to the development of medical educational training programs in Senegal. However, for the foreseeable future, the developments in Senegal remain quite separate from the on-going pre-clinical program education in Luton, England and the established clinical clerkships in the United States.

In 2002, with the assistance of Mr. Neil Warnock, formerly a financial-aid administrator for Kigezi International School of Medicine, Saint Christopher's College of Medicine established the Med-Achiever Loan program through Key Bank.

In 2003, four administrators have been added to the staff in the New Jersey office. Two administrators, Mr. William Cundiff, JD, MBA, recently appointed as Director of Operations and Mr. Robert D. Fave, recently appointed as Clinical Director, came to Saint Christopher's College of Medicine with foreign medical education experience.

In September 2003, the number of students enrolled has grown to over 100 students per semester.

In 2003, to assure more continuity in the pre-clinical program, several full-time faculty appointments have been made in Luton. This has created a core of well-qualified, full-time faculty in biochemistry, physiology and medical microbiology who can also serve the important function as academic advisors. The full-time faculty, together with the visiting part-time medical specialists, brings a balance to the classroom and a commitment to deliver the highest possible quality in medical education.

The growth of Saint Christopher's College of Medicine is due to the efforts of many people who share a common goal, namely, to make a quality medical education more readily available for deserving students. However, it is the vision, drive and commitment of, Dr. Paul Leone that has made this achievement possible.

ELIGIBILITY FOR LICENSURE

The graduates of Saint Christopher's College of Medicine are eligible for licensure in the Republic of Senegal, subject to immigration laws and the qualification examinations.

The graduates of Saint Christopher's College of Medicine are eligible for certification by the Educational Commission of Foreign Medical Graduates (ECFMG) and therefore eligible for licensure in 37 states within the United States of America.

In addition, the graduates of Saint Christopher's College of Medicine are eligible for "Limited Registration" in the United Kingdom, which allows 5 years of post-graduate training in hospital.

In due course, application shall be made for degree-granting authority to the Bureau of Post-Secondary Private Education in the State of California.

The Admissions Review Board (ARB) gives serious consideration to all candidates showing the potential to meet the rigorous academic requirements of a highly structured curriculum.

The Admissions Review Board considers each applicant for admission based on a combination of factors including: undergraduate cumulative grade point average, grade point average in required pre-medical course work, advanced Biology and Chemistry courses, graduate level work, letters of recommendation, and the personal essay. The personal interview provides the Admissions Review Board with an assessment of the applicant's background, maturity, aptitude, and in particular, motivation for the study of medicine. MCAT scores, work history, and professional or volunteer experiences also provide further evidence of the student's motivation.

Applicants whose credentials are judged to be indicative of the potential for successful completion of the prescribed curriculum will be invited for an interview, generally within two to four weeks after all application materials have been received. Persons whose applications are incomplete, or whose qualifications are not acceptable, will be so notified. A letter to the applicant that communicates the decision by the Admissions Review Board shall be sent as soon as possible after the interview.

Saint Christopher's College of Medicine highly recommends, but does not require the Medical College Admission Test (MCAT).

Admissions are granted without regard to race, religion, color, gender, age, marital status or origin.

Applicants are expected to have earned a Bachelors degree (or equivalent) from an American, Canadian, or other internationally recognized college or university. Occasionally applicants qualify for admission upon the completion of 90 credits (i.e. three full-time years) of baccalaureate pre-medical studies. In any case, pre-medical studies must include the following courses:

Inorganic and General Chemistry (with labs)	1 Year
Organic Chemistry (with labs)	1 year
General Biology or Zoology (with labs)	1 year
Physics (with labs)	1 year
College-level Mathematics (preferably to include Calculus or Statistics)	1 year
English	1 Year

It is also strongly advised that courses providing a broad background in the humanities be part of the pre-medical preparation. At least 16 additional credit hours in non-science courses is also expected. A biochemistry course is encouraged.

Applicants who have completed their undergraduate studies in countries having an educational system different from that of the United States will be evaluated on their merits but will be expected to have completed a pre-medical curriculum comparable to that described above. All required documents, if originally in a foreign language, must be accompanied by a notarized English translation. All transcripts documenting post-secondary course work completed in institutions outside the United States must also be evaluated by an approved international credential evaluation service. Contact the Admissions Office for more information on these matters.

Applicants presenting less than sixty upper-division credits from an English language college or university must provide the official record of the scores for the Test of English as a Foreign Language (TOEFL). The minimum acceptable score is 550 on the paper-based test or 213 on the computer-based test.

A complete application consists of the following documents, which should be sent to the attention of the Admissions Office at Saint Christopher's College of Medicine:

- A completed application form

- Application/Interview fee of \$100 US
- Two official letters of recommendation. These should include one from a pre-medical professor acquainted with the applicant's academic ability, and one from a physician who is familiar with the applicant's experience in a health care setting, if available. Committee recommendations from colleges and universities are acceptable. No more than 3 letters total should be sent. All letters must be sent directly to Saint Christopher's College of Medicine.
- Official transcript(s) of grades from each college and professional school attended, mailed directly to Saint Christopher's College of Medicine from the issuing institution.
- Official report of scores on the Medical College Admission Test (MCAT) is highly recommended, but not required.
- Official report of scores on the TOEFL (for applicants whose academic background has been substantially in languages other than English).
- Official transcript from prior medical school (for advanced standing).

Once applicants have been accepted, the Admissions Department will advise them on all aspects of their preparation for living and studying in Luton. Prior to enrollment, all accepted students must submit to the Admissions Office, a health certificate, which must include a current list of immunizations as well as a current tuberculin (TB) test.

There are certain additional documents required by the government for immigration purposes, and are necessary in order to obtain a Visa. These include:

- Letter of good conduct from the student's local police department
- Original Health Certificate
- Valid passport (Copy to be sent to Saint Christopher's College of Medicine in the USA)
- Four color 2"x2" passport-size photographs, signed on the back
- Visa Application Fee of \$20
- Proof of roundtrip airplane ticket

Students should submit these items to the Admissions Office four weeks prior to arriving in Luton, if possible. Upon acceptance, Saint Christopher's College of Medicine will assist

students in completing the visa application process before they arrive in Luton. In the majority of cases, the actual visa will be received once the student arrives in Luton.

Students enrolled, or previously enrolled, in a limited number of approved medical schools may apply for admission with advanced standing. Such applicants must arrange with the medical school they are attending for submission to Saint Christopher's College of Medicine an official transcript of their academic record at that school. It is also the applicant's responsibility to furnish official course descriptions and course-by-course evaluations of the work they have completed; if necessary, these must be attested to by an approved international credentials evaluation agency. Additionally, a letter of recommendation from the academic dean at the previous medical school must be submitted. The Admissions Review Board will determine level of placement in the curriculum of accepted transfer students.

Generally, transfer credit cannot be extended beyond two years for applicants who have not been attending medical school for more than that period of time. Transfer students who have completed part or all of the Basic Science may be placed in the second or third semester of the Saint Christopher's College of Medicine Basic Science curriculum

No accepted transfer applicant will be placed beyond the fourth semester of the curriculum. Therefore, all students accepted for transfer, regardless of their previous training, and USMLE scores, must enroll for at least two semesters on the Basic Science campus in Luton prior to matriculating in the Clinical Science Division. During the two semesters, students will be required to take Introduction to Clinical Medicine I and II. This includes those transfer students who have previously taken and passed the USMLE Step I.

Transfer credit can not be given for incomplete or failed courses, or for courses taken more than four years prior to the time the applicant is accepted for enrollment at Saint Christopher's College of Medicine.
