Dear Mr. Lea:

On September 11-12, 2003, the National Committee on Foreign Medical Education and Accreditation (NCFMEA) met in Washington, D.C., to review materials from 14 countries, including the information and documentation provided by the Irish Medical Council (Medical Council) in order to reassess the comparability of Ireland's medical accreditation standards to those used in the United States. At the meeting, the NCFMEA members also heard testimony from Dr. Gerard Bury, President of the Medical Council. His testimony was most helpful and the NCFMEA members wish to thank him for his participation in the meeting.

I am pleased to inform you that the NCFMEA, based on the materials submitted by the Medical Council and testimony presented by Dr. Bury, reaffirmed its prior determination that the standards and processes used by the Medical Council to accredit medical schools in Ireland are comparable to those used to accredit medical schools in the United States. This determination of comparability by the NCFMEA has a maximum duration of six years from the date of this letter, unless the Committee withdraws, extends or renews its determination prior to that date. Before expiration of the six-year period, the NCFMEA will seek to confirm that your standards and processes for accrediting medical schools in Ireland are still comparable to the accreditation standards applied to medical schools in the United States. If so, its previous determination of comparability will be extended for another period.

As a result of the determination of continued comparability by the NCFMEA, any medical school in Ireland that is accredited by the Medical Council may apply to the U.S. Department of Education to participate in the Federal Family Education Loan (FFEL) program. If a medical school's application is approved, students enrolled in the school who are either U.S. citizens or permanent residents of the U.S. may receive FFEL loans to finance their medical education if they meet all other eligibility requirements. Medical schools that wish to participate in the FFEL program may obtain the proper application forms from the Foreign Schools Team by calling (202) 377-3168 or by writing to the address below. Please note, however, that it is not necessary for medical schools that are currently participating in the FFEL program to contact the Foreign Schools Team at this time; the status of those schools remains unchanged by the NCFMEA's decision of continued comparability.



Content: The purpose of the report is to provide the NCFMEA with a summary of the accreditation activities involving the medical schools in Ireland, including the following information (and any applicable supporting documents):

- *Current status of medical schools:* A list of the medical schools currently operating in Ireland, indicating the most recent date the school has gone through the accreditation review process and the school's current accreditation status (such as fully accredited, provisionally accredited, etc.).
- *Overview of accreditation activities:* A summary of key activities by the Medical Council during the period covering September 2003 – May 2004, such as a list of accreditation reviews conducted, meetings held and accreditation decisions reached, and accreditation conferences or training sessions held.
- *Laws and regulations:* An indication as to whether there have been any changes since September 2003 in your country's laws or regulations that affect the accreditation of your medical schools, and if so, what those changes were.
- *Standards:* An indication as to whether there have been any changes since September 2003 in the accreditation standards that the Medical Council uses to evaluate and accredit medical schools in the areas listed below, and if so, what those changes were:
 - administration,
 - faculty,
 - curriculum,
 - admissions procedures,
 - student services,
 - methods for evaluating student achievement, and
 - facilities.

- ***Processes and procedures:*** An indication as to whether there have been any changes since September 2003 in the accreditation processes and procedures used by the Medical Council for the following:
 - conducting site visits.
 - selecting and training individuals who conduct site evaluations or who make accreditation decisions.
 - periodically reevaluating and regularly monitoring medical schools.
 - reviewing substantive changes reported by medical schools.
 - ensuring the Medical Council has effective controls against conflicts of interest and the inconsistent application of accreditation standards, and
 - ensuring that accreditation decisions are based, in part, on the evaluation of student performance after graduation from medical school.

- ***Schedule of upcoming accreditation activities:*** A listing of upcoming accreditation meetings and on-site visits to medical schools and clinical clerkship sites for the period covering July 2004 through June 2005.
